Payment & Refund Information

There will be no refunds given after the 1st class of each month unless medically necessary. If your child drops out prior to the 1st class of the month, **we MUST be notified IN WRITING in order to open that spot up for another child. If you fail to notify us IN WRITING, by the 1st of the month, you will be responsible for the tuition for that month.** Drops will not be accepted via telephone or by notifying the instructor. A parent/legal guardian must notify the business office. When you register a child for a class, they own that spot for the entire session (Sept.-June).

However, we understand that gymnastics does not appeal to every child and many children do other activities. If a child takes only one class and decides that it is not for them, there will be a one time charge for the class (at an adjustable rate), and all other monies will be refunded. (This does not refer to a trial class.) If the child drops out within their first month, and we have been notified IN WRITING, then the registration fee will **NOT** be refunded and you will be responsible for that month's tuition only.

Nutmeg Twisters accepts payments of cash, check, bank transfer and all major credit cards. There is a 3.75% finance charge if a credit card is used to make payment via telephone or automatic withdrawal.

*Monthly payments are averaged out for total number of classes and account for any scheduled days off. (Holidays, vacations, etc.) Payments are broken into 9 equal monthly installments, regardless of the amount of classes offered in that month. If registration is after September, an additional charge may be applied to that 1st month's tuition. *
